## FINAL AMENDMENT TO TENDER OFFER STATEMENT

This Amendment No. 2 supplements and amends the Schedule TO filed with the Securities and Exchange Commission on November 16, 2015, as supplemented and amended on December 23, 2015, by HMS Income Fund, Inc., an externally managed, non-diversified, closed-end management investment company incorporated in Maryland (the "Company"), in connection with the offer by the Company to purchase up to 1,010,168.63 shares of its issued and outstanding common stock, par value \$0.001 per share (the "Shares"). The tender offer was made upon, and subject to, the terms and conditions set forth in the Offer to Purchase, dated November 16, 2015, and the related Letter of Transmittal (together, the "Offer"). The Offer terminated at 5:00 P.M., Central Time, on December 18, 2015, and 191,533.70 Shares were validly tendered and not withdrawn pursuant to the Offer as of such date. In accordance with the terms of the Offer, the Company purchased on December 23, 2015 (the initial funding date) 190,610.88 Shares validly tendered and not withdrawn on such date, and on December 28, 2015 and December 29, 2015 (the additional funding dates), the Company purchased an additional 542.11 Shares and 380.71 Shares, respectively, validly tendered and not withdrawn, in each case at a price of \$7.88 per Share, which was the net asset value per share as of December 22, 2015, for an aggregate purchase price of approximately \$1,509,285.56.
